RCI is a timeshare exchange company which gives WorldMarkSP Owners the opportunity to exchange to other timeshare properties around the world. RCI has over 3.8 million members who are all timeshare Owners of some sort. RCI has over 4,300 affiliated resorts in more than 110 countries, so there's lots of flexibility and choice when travelling through RCI. Privileges members are automatically enrolled as RCI members upon signing up to Privileges membership. An RCI membership number is printed on your WorldMarkSP Owner Card – the card can take up to 6 weeks to be posted from account activation with WorldMarkSP. WorldMarkSP Premier Owners can join RCI by paying an annual fee.

What Are RCI Elite Benefits?

RCI Elite Benefits provides four key membership enhancements, which are offered offered exclusively by RCI to Privileges Elite members and above, including discounts on exchanges, complimentary Guest Certificates, Spacebank extensions and RCI Cancellation Protection.

Please Note: These benefits are not available when exchanging online and may only be redeemed by contacting RCI by phone.

Discount Exchanges

Privileges Elite members and above receive ongoing discounts each time you make an exchange with your Vacation Credits from your WorldMarkSP Ownership account to your RCI account.

This offer is available by contacting an RCI consultant over the phone only.

You must request the discount at time of making the exchange with an RCI Consultant.

Guest Certificates

You can share the fun of RCI holidays with friends and family by giving a free Guest Certificate to your loved ones. You receive one complimentary Guest Certificate once per calendar year, which is valued at AU\$30.

To book using a Guest Certificate, you must call an RCI Consultant, confirm a reservation and add the Guest Certificate to the booking, which allows you to add your friends/family members name to the reservation – therefore the friends/family members can travel on the reservation instead of yourself.

Spacebank Extension

Spacebank extension provides a free three-month extension when you are Spacebanking your Vacation Credits. Vacation Credits can usually be banked in the Spacebank for up to two years, therefore the Spacebank extension allows Vacation Credits to be banked for up to two years and three months in total. To utilise this extension, you must call an RCI Consultant and request the extension.

This benefit can be used once every Anniversary Year.

Please Note: You must book and travel within the Spacebanked period.

RCI Cancellation Protection

If you have to cancel your holiday due to any circumstances, you can call an RCI Consultant who will waive the cancellation fee on your booking, when cancelled more than 45 days in advance.

This benefit can be used once per calendar year.
