Tourism Services Tax (TST)

The Fiji Government has introduced a Tourism Services Tax (TST) of 5% on tourism industry accommodation and services, effective 1 September 2026.

This tax will be charged directly to owners and guests and collected by the resort on behalf of the Fiji Revenue & Customs Service (FRCS). The TST will be calculated upon the length of your stay and room type and added to your room account, for payment to the resort upon check-out.

This government-imposed tax is mandatory and the resort will be remitting to FRCS for your stay.
